M433: Critical Thinking and Problem Solving Advance Sheet

1. SCOPE:

This lesson establishes the foundation of the ability to think and to solve problems. We accomplish lesson objectives by means of advance readings, classroom discussion, and practice in the form of a practical exercise. Analyzing a contemporary issue confronting today's military helps to accentuate the concepts in problem solving and critical thinking. The practical exercise highlights the importance of sound thinking when dealing with unfamiliar situations. This lesson focuses learners on how to think rather than on what to do. This lesson reviews the steps to solving problems and the fundamental concepts of thinking. After this lesson, the learners are ready to solve problems in cohesive teams and provide logical solutions.

This lesson ties back to the Senior Enlisted Joint Professional Military Education II (SEJPME II) course. This lesson supports The Army Profession, Ethic, and Leadership (ADP 6-22) of honorable service, military expertise and esprit de corps. This lesson is the backbone of the Master Leader Course. Students must be able to critically and creatively think to solve the problems presented in learning activities. This lesson prepares students for DLC V.

- 1. Determining critical thinking processes; and
- 2. Ensuring the quality of a decision.
