- 1. Purpose: To identify establishments operating in southeastern Virginia and Northeastern North Carolina areas that are declared off limits to Armed Forces Personnel.
- 2. <u>Information:</u> As a result of recommendations by the Armed Forces Disciplinary Control Board (AFDCB), and the Off-Installation Military Enforcement Services instructions for Southeastern Virginia and Northeastern North Carolina, and acting in accordance with references (a), (b), and (c) the below listed establishments are off limits to members of the Armed Forces:

 - e. Outer Edge Gifts, 760-B J. Clyde Morris Blvd, Newport News, Virginia 23601.
 - f. City's custom & Design AKA Envy Car Audio and Design AKA. Unique Auto Design, 1602 37th Street, Norfolk, Virginia 23508 or 117 Princess Anne Rd, Norfolk, Virginia 23510, Autoworks, 6100 Tidewater Dr., Norfolk, Virginia 23509, and D Motors, 881 E. Little Creek Road, Norfolk, Virginia 23518.
